

Ohio law requires that all dogs over the age of three (3) months must be licensed annually by January 31 (extended to February 28). Rabies tags or I.D. tags do not qualify.

For your convenience, you may secure your dog license in any one (1) of the following three (3) ways:

1. You may register by mail by completing the form below and enclosing a check or money order for the total amount of the 1 year, 3 year and/or permanent tags, payable to: **MAHONING COUNTY TREASURER**. Submit the payment and a **self-addressed stamped envelope** (so the dog tag(s) and receipt may be returned to you) to the following location:

2. You may personally purchase a 1 year dog license from any designated dog license agency in Mahoning County. For the location of these agencies go to <http://auditor.mahoningcountyoh.gov> or call the Auditor's Office at 330-740-2010.
3. You may register on-line by going to: <http://dogtags.mahoningcountyoh.gov> and follow the directions to renew a dog license.
4. The Deadline is January 31, 2021, extended to February 28, 2021. If a license has not been purchased by the deadline you may be subject to a Dog Warden visit and a court citation.
5. Tags are **NON-TRANSFERABLE** and **NON-REFUNDABLE**.

Certification of registration and registration tags shall be valid only during the calendar year or years in which they are issued, O.R.C. Sec. 955.09

A penalty shall be assessed if Dog License is not secured on or before January 31, or within 30 days after dog becomes 3 months of age or is brought from outside the state. O.R.C. Sec. 955.01.

Sec. 955.01. (A)(1) states every person who owns, keeps or harbors a dog more than 3 months of age shall file, by the deadline, in the office of the county auditor in which the dog is harbored, an application for registration for a period of one year or three years or an application for a permanent registration.
